

New Relic LEGO® Collectibles Sweepstakes

Official Rules

The New Relic 2021 LEGO® Collectibles Sweepstakes (the “Sweepstakes”) will be held between 8:00am PT on November 3rd, 2021, through 11:59pm PT on November 19, 2021 (the “Sweepstakes Period”). Participants may be eligible to win the prize detailed below.

How to Enter:

To enter the Sweepstakes, participants must be a registered member of Twitter, Instagram, LinkedIn, or Facebook with an active account in good standing. To become a member of one of these social media sites, go to www.twitter.com, www.facebook.com, www.instagram.com, or www.linkedin.com and follow the sign-up instructions to create an account.

Beginning on November 3rd, 2021, New Relic will be inviting eligible participants to participate in the Sweepstakes. To enter the Sweepstakes, eligible participants must register for Data Nerd Days AMER 2021 via the registration link at <https://hopin.com/events/data-nerd-days-2-0>, log in, watch a minimum of two full sessions, and post a screenshot from at least one session on their Twitter, Instagram, LinkedIn, or Facebook account containing the hashtag #DataNerdDays and tagging New Relic within the post during the Sweepstakes Period (an “Entry”). The Sweepstakes is limited to one Entry per participant. This prize is non-transferable and has no cash value.

The winner will be notified via direct message on the social media platform on which they submitted their Entry within forty-eight (48) hours after the drawing. Upon signing an eligibility affidavit and waiver, the winner can arrange to be mailed the prize detailed below. If a winner does not claim their prize within two (2) weeks of the drawing, they shall forfeit their prize and a new winner shall be selected. Participants’ odds of receiving the prize are dependent on the number of eligible Entries received.
